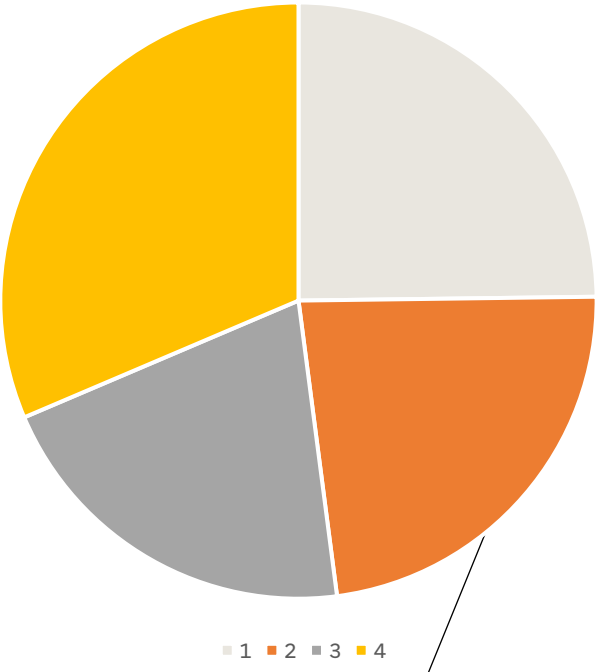

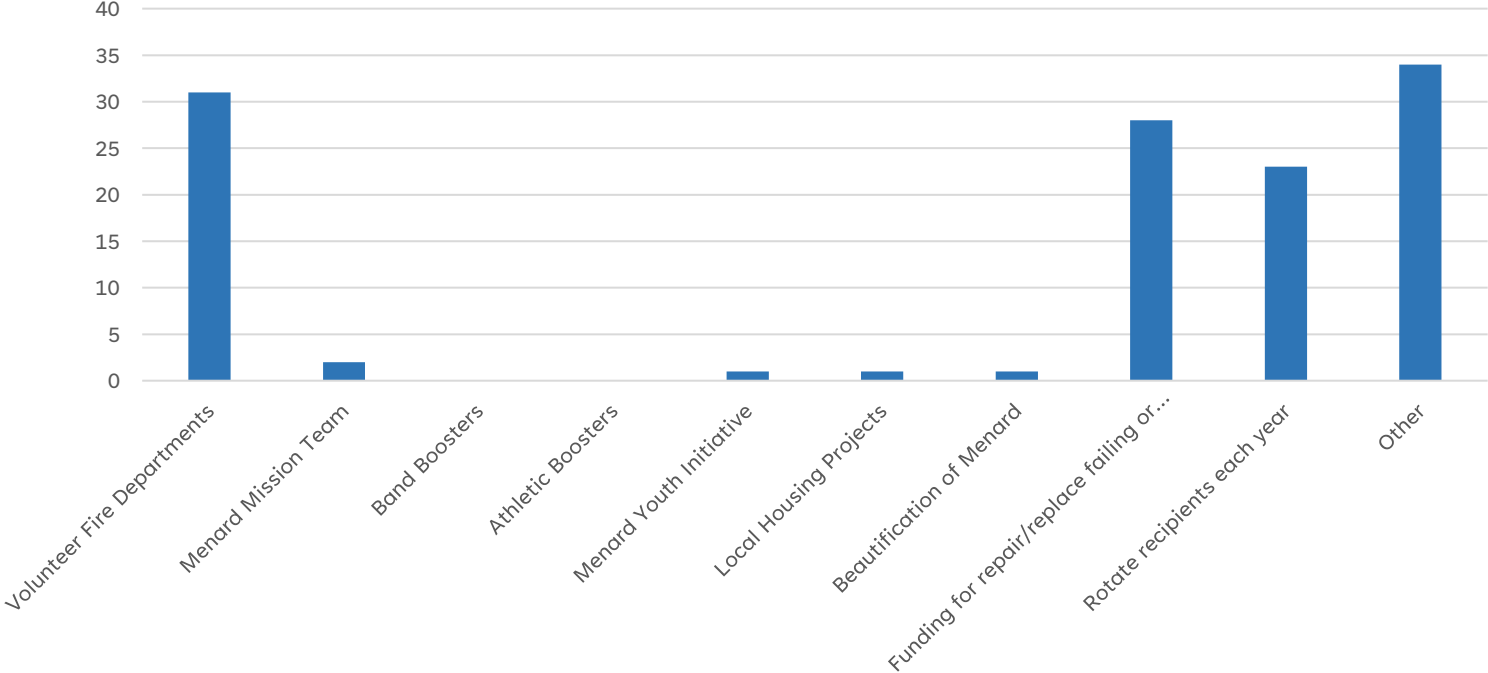

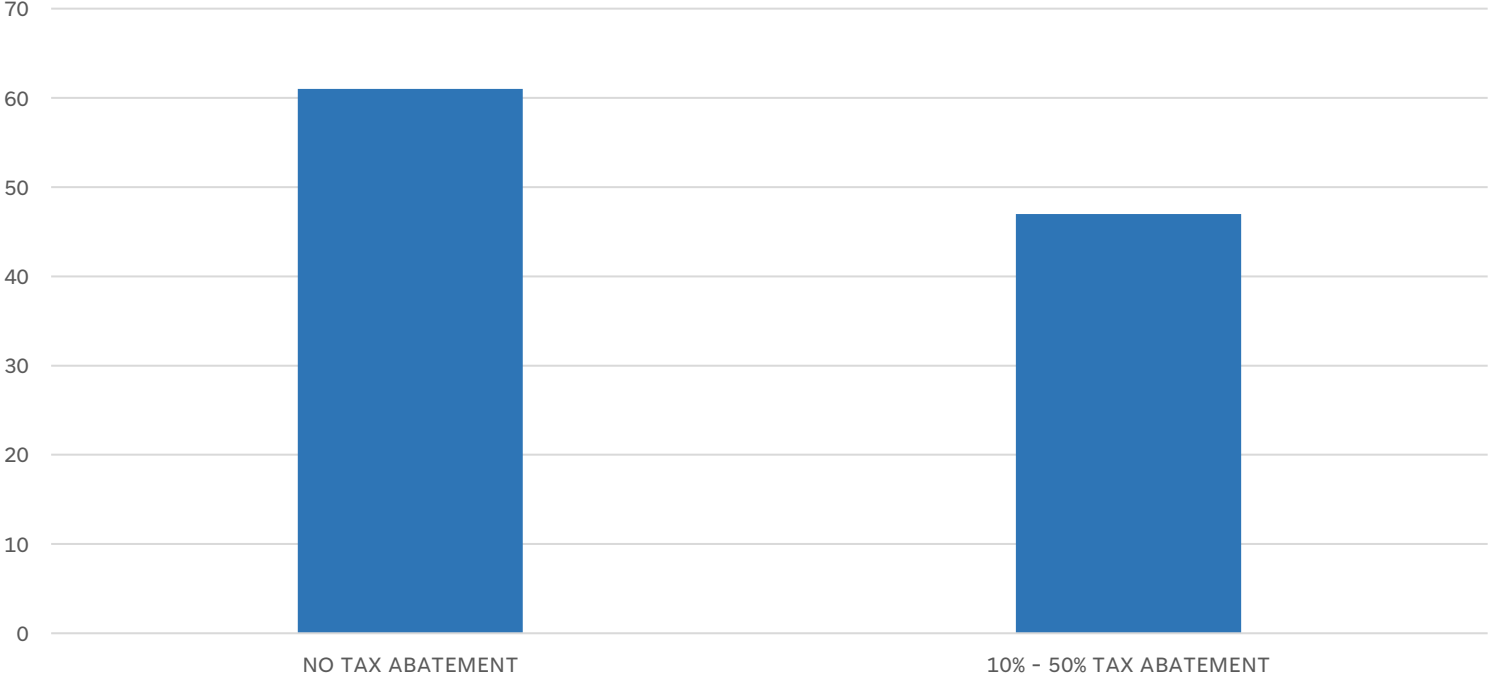
PRECINCT DISTRIBUTION



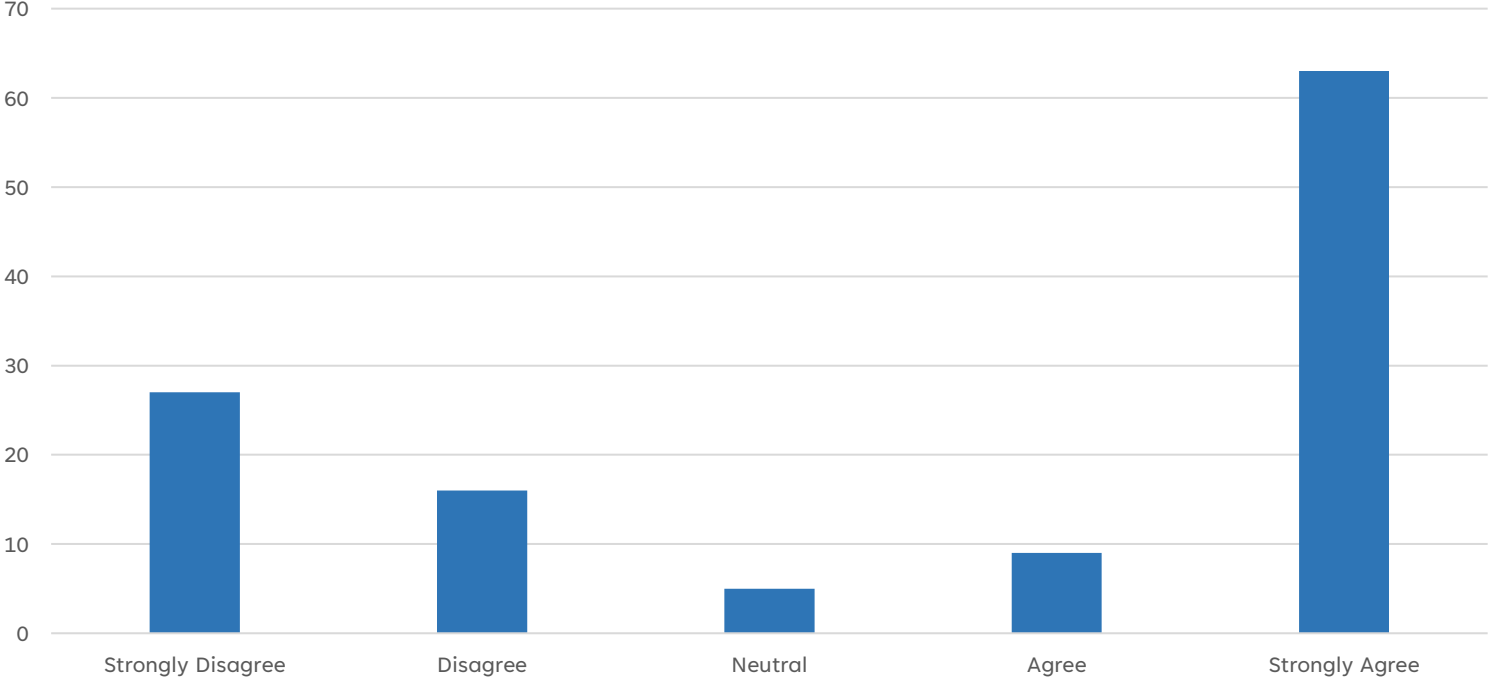
CHARITY GROUP PREFERENCES



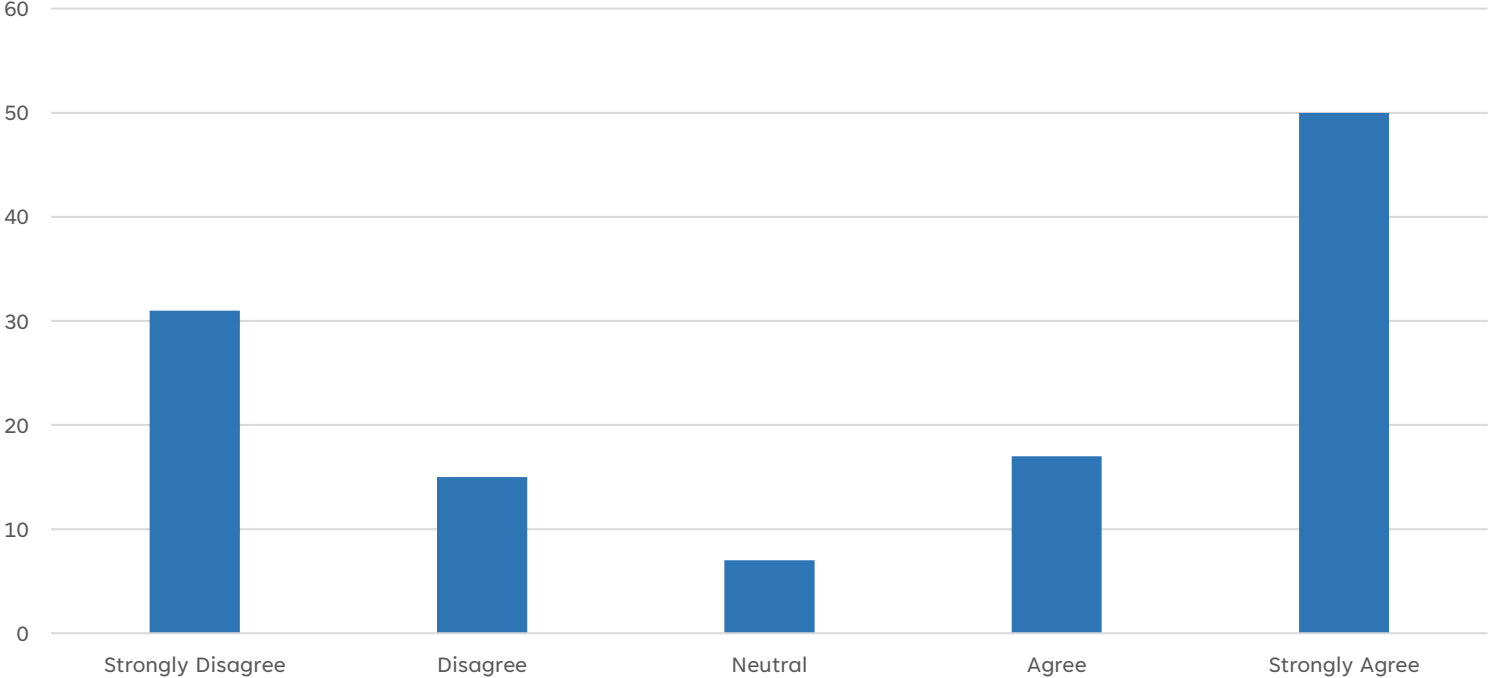

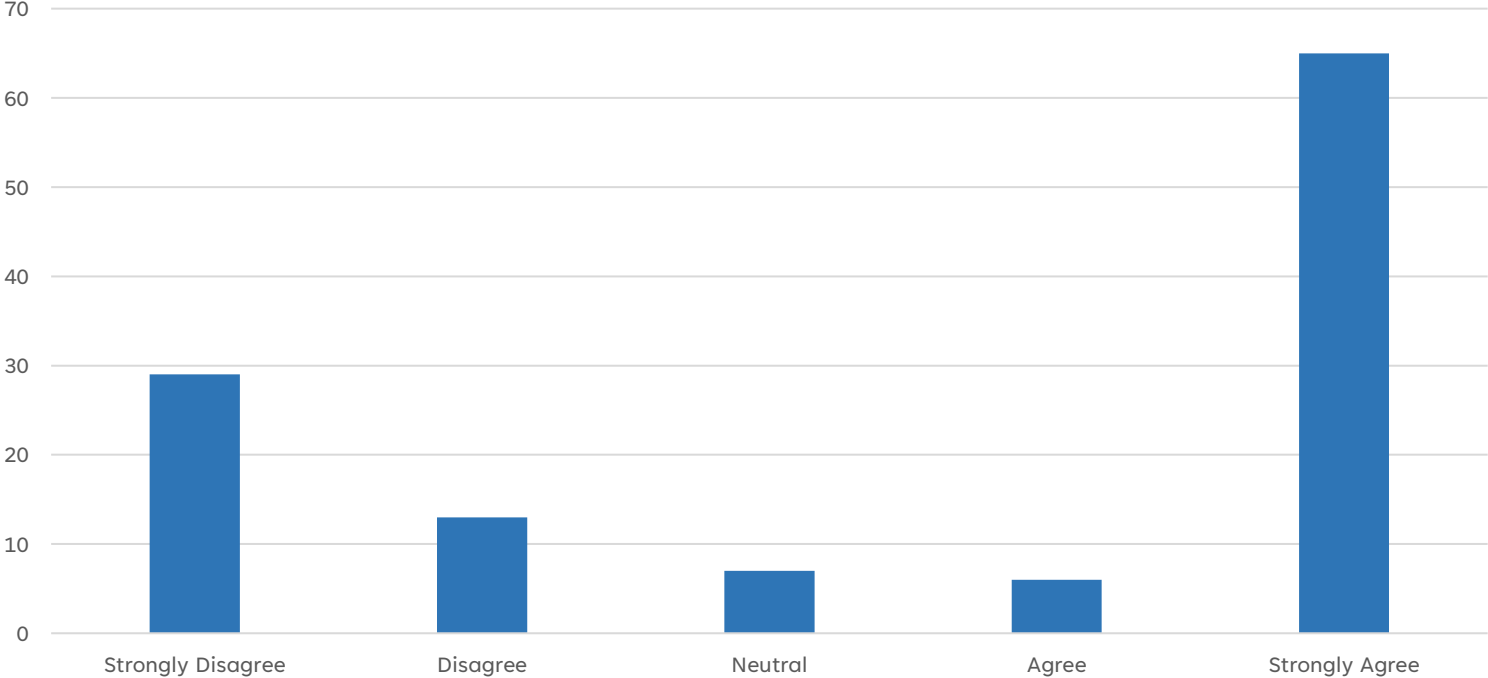

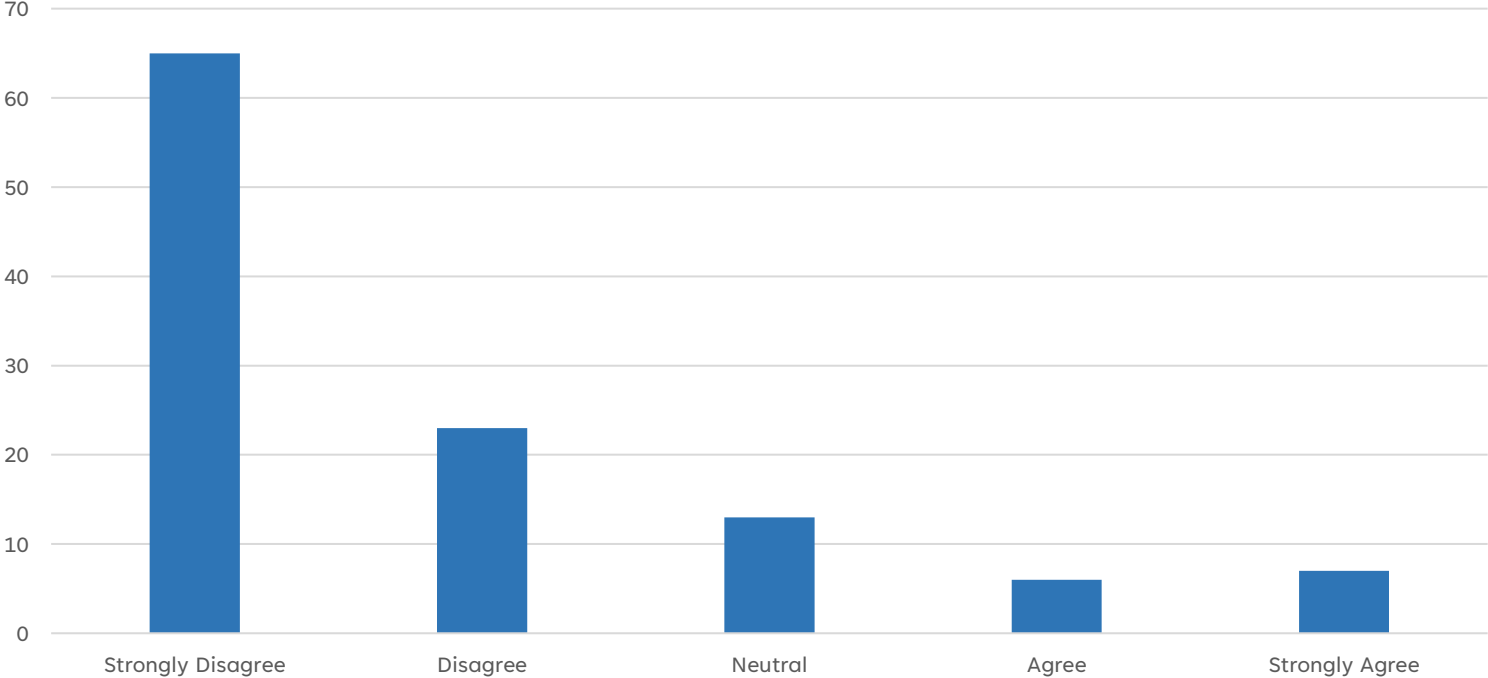
Q2: I AM CONCERNED ABOUT NOISE POLLUTION FROM THE SITE



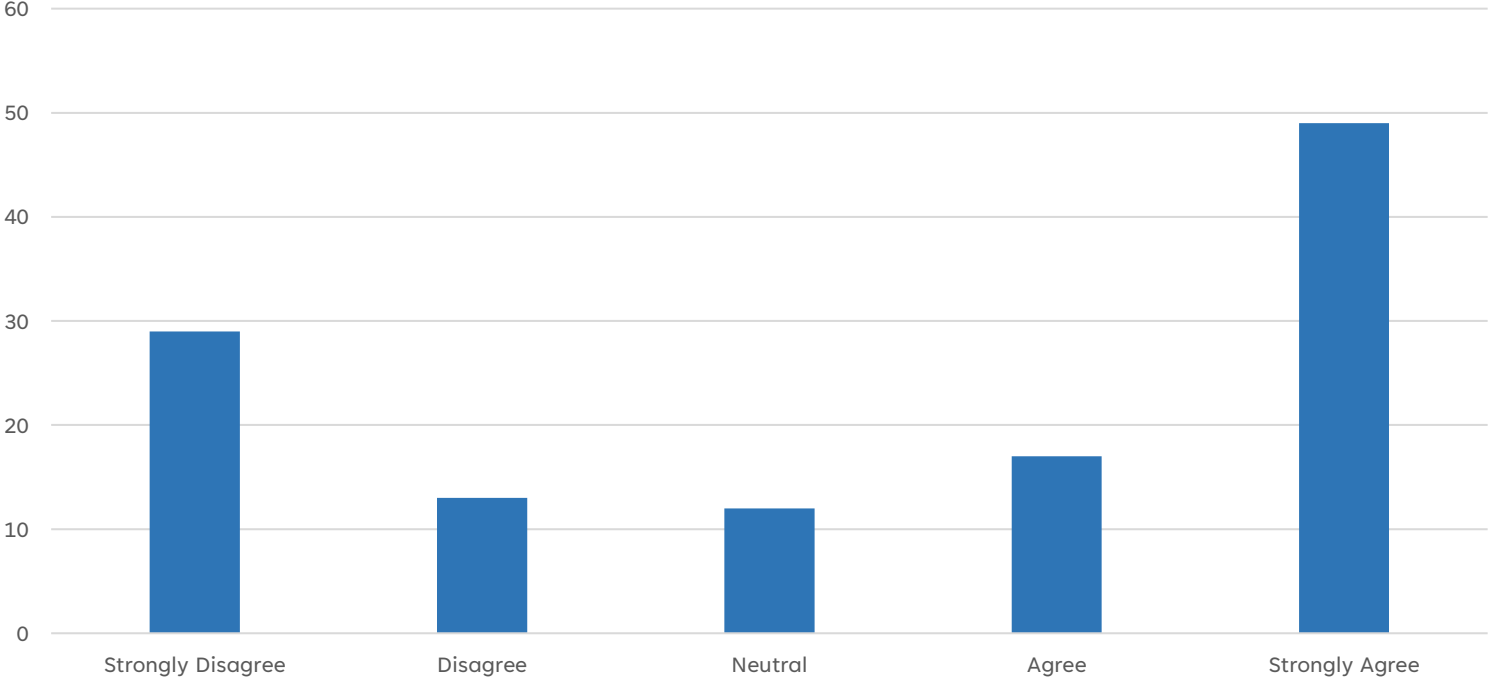
Q3: I AM CONCERNED ABOUT POTENTIAL WATER CONTAMINATION



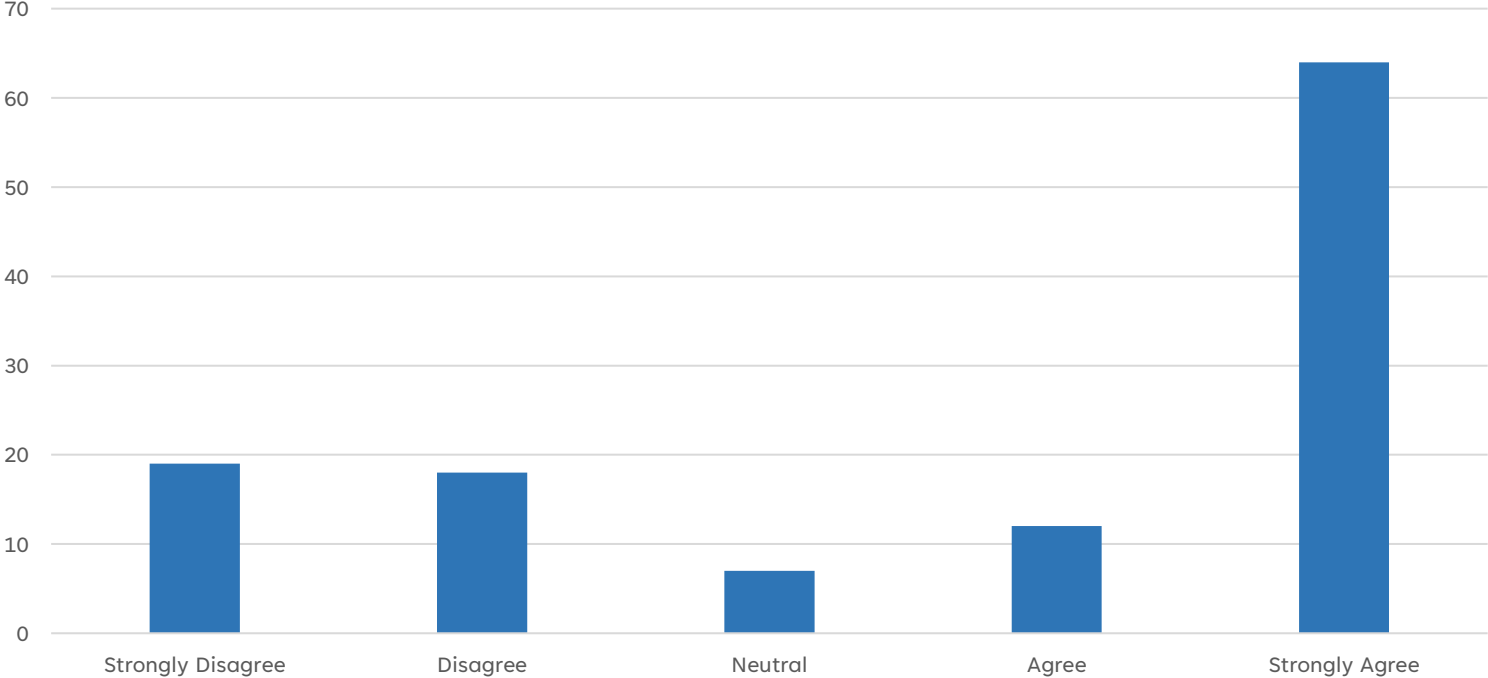

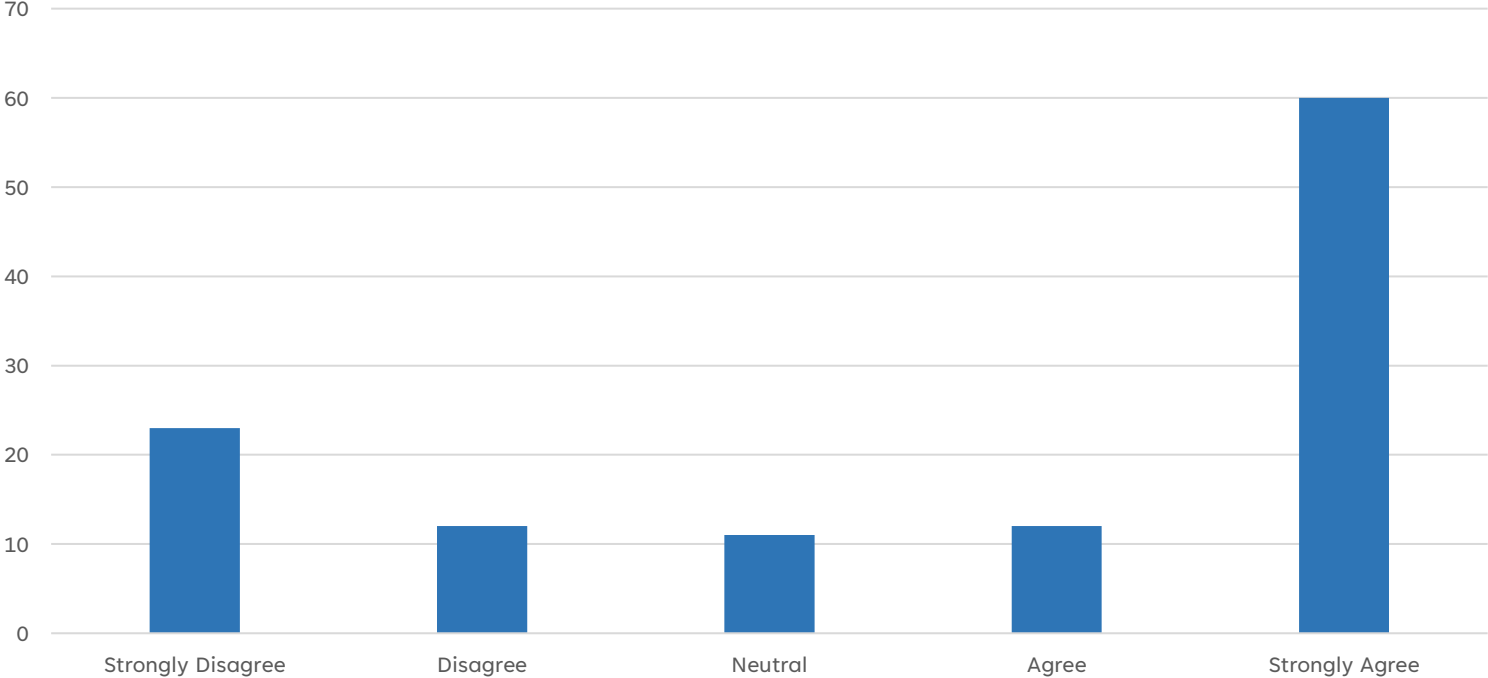
Q5: I AM CONCERNED ABOUT THE SITE'S CYBER SECURITY



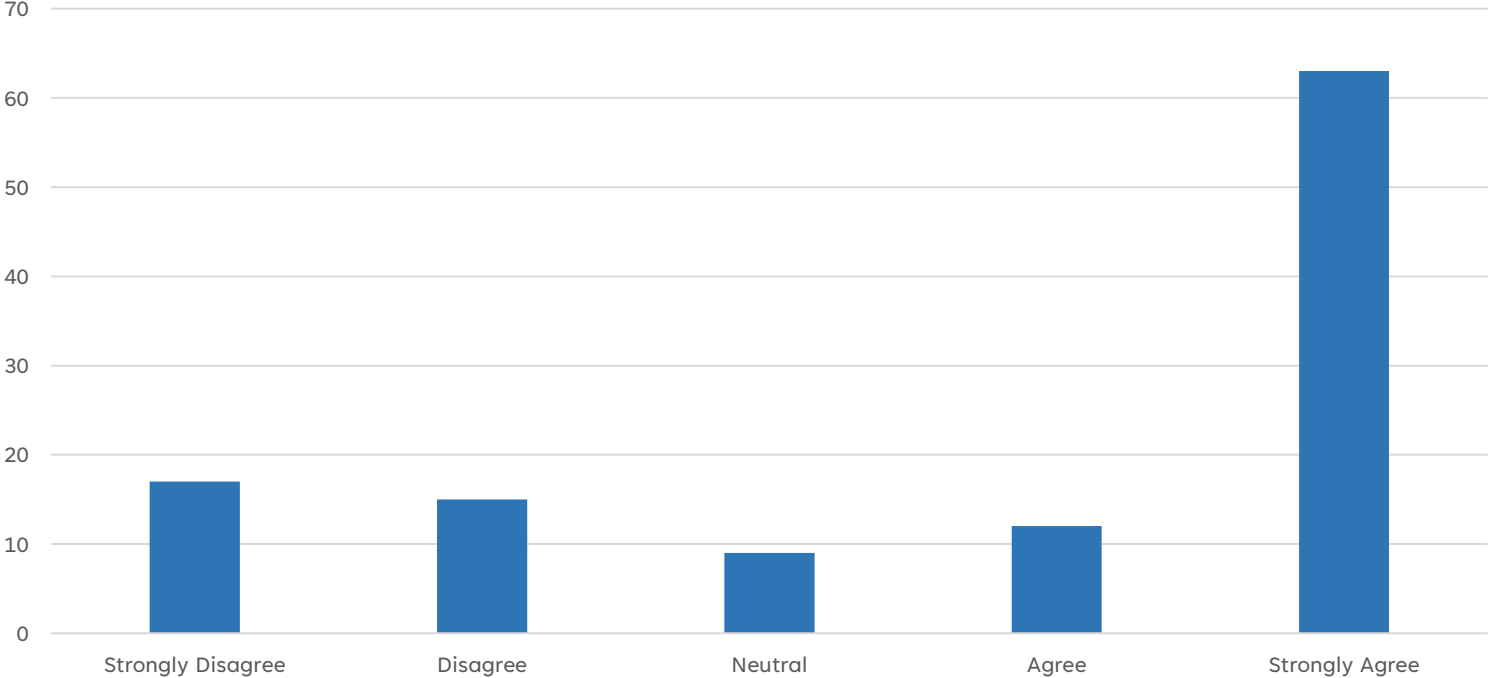
Q6: I AM CONCERNED ABOUT FOREIGN OWNERSHIP POTENTIAL



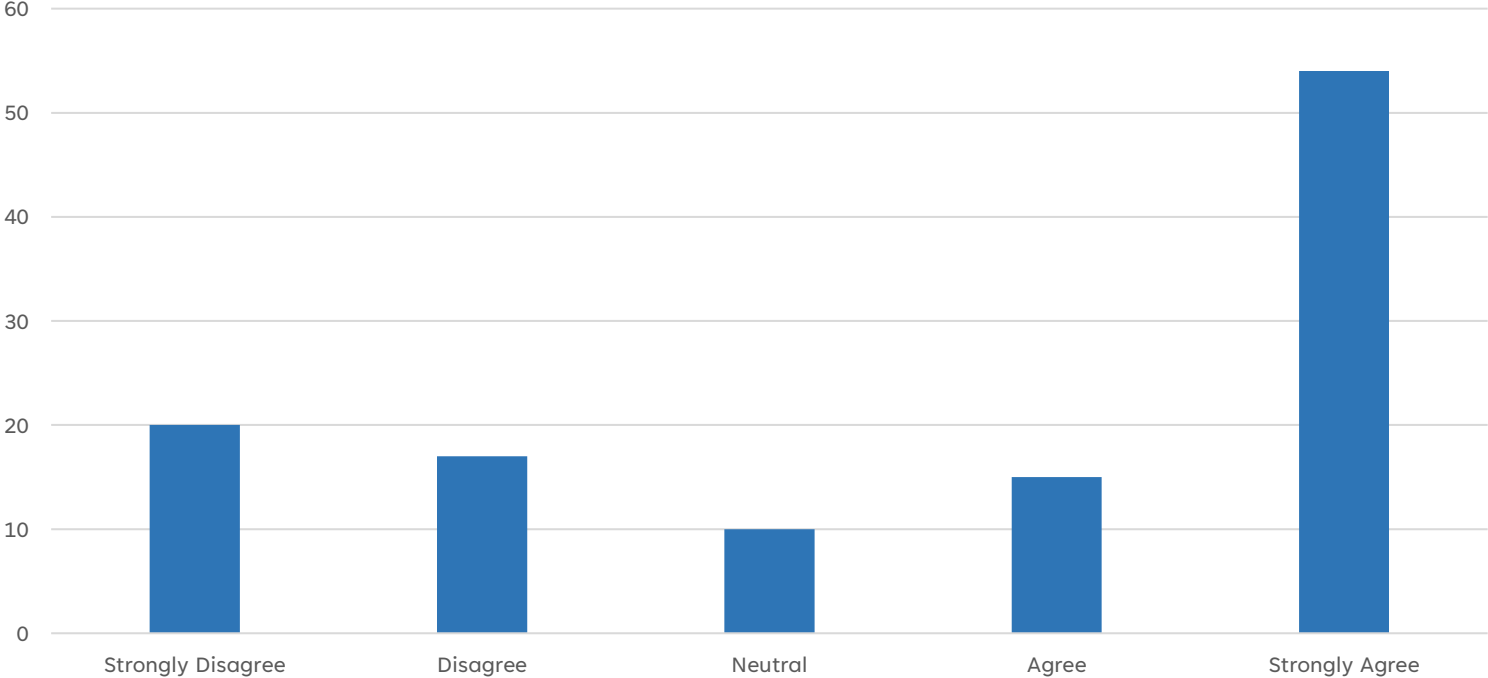

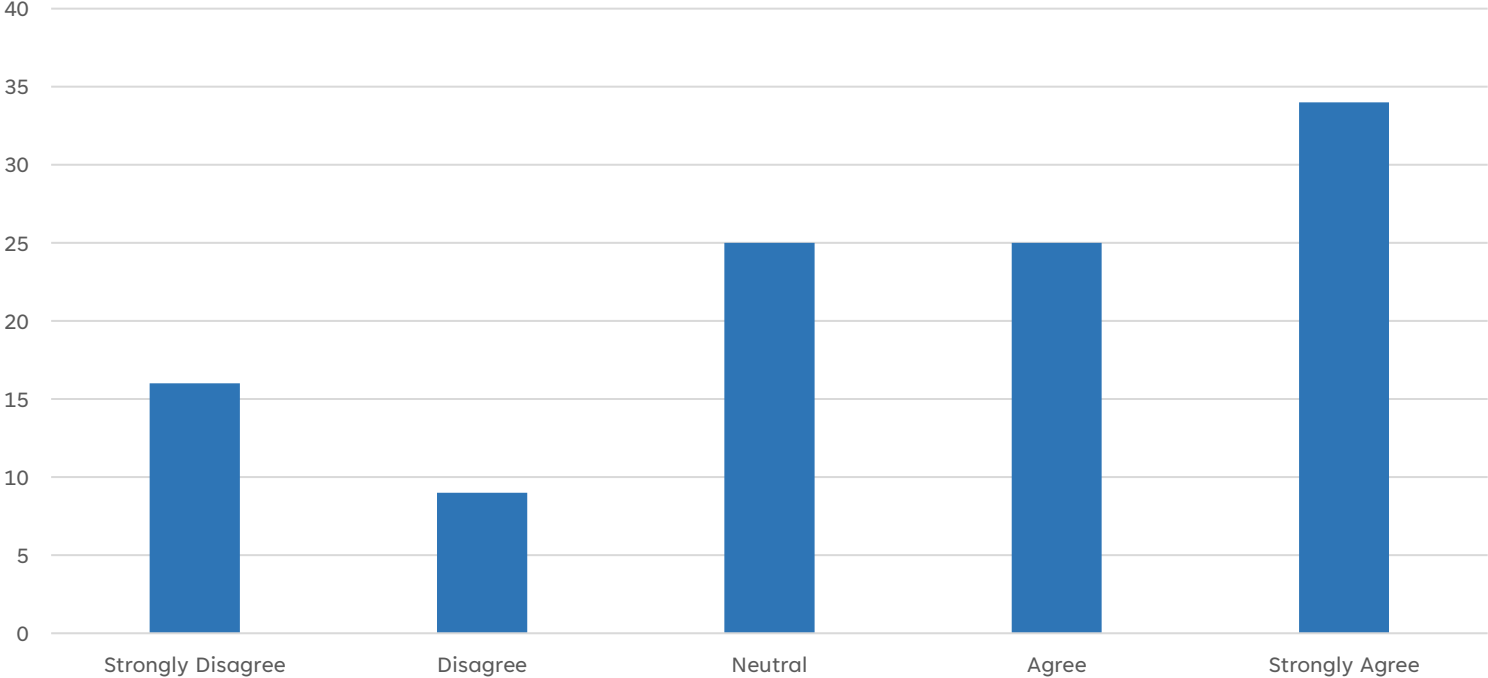
Q8: I AM CONCERNED ABOUT THE DECONSTRUCTION AT END OF LIFE/ENVIRONMENTAL IMPACT



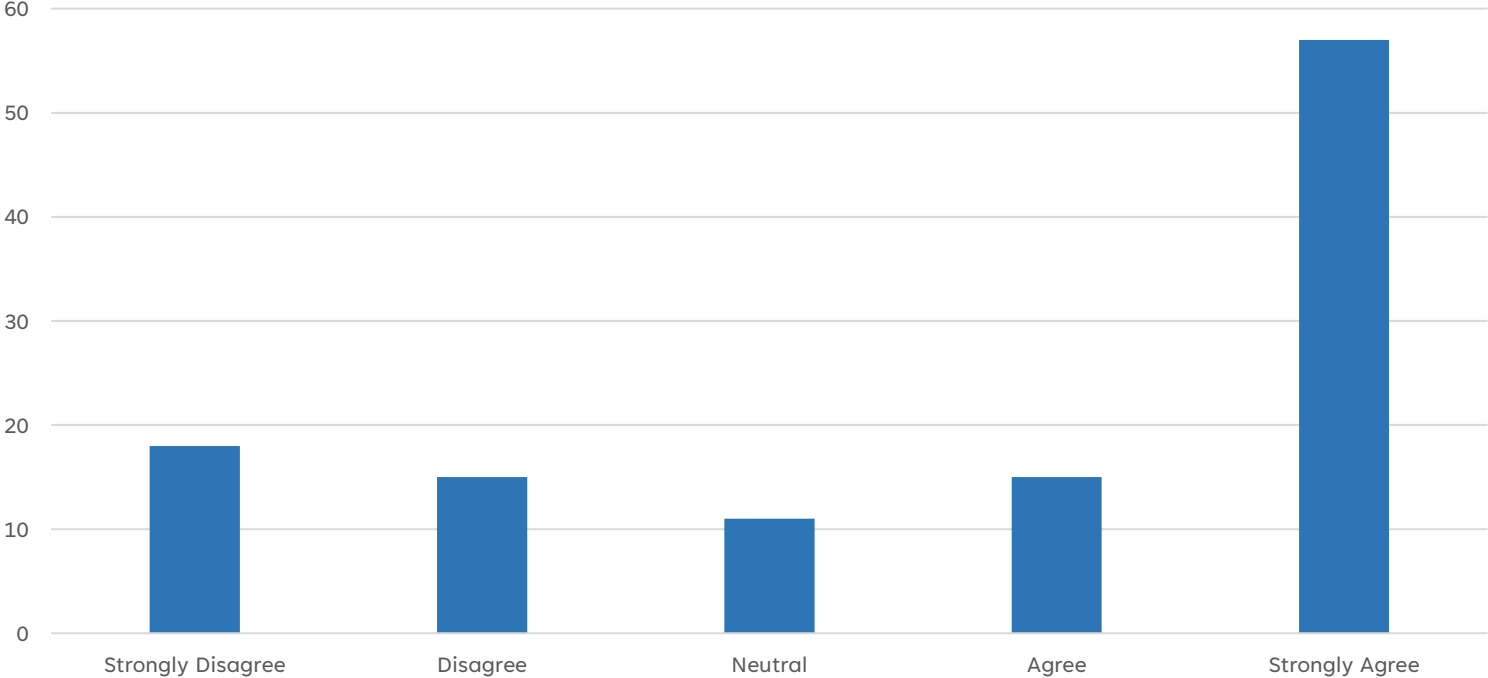

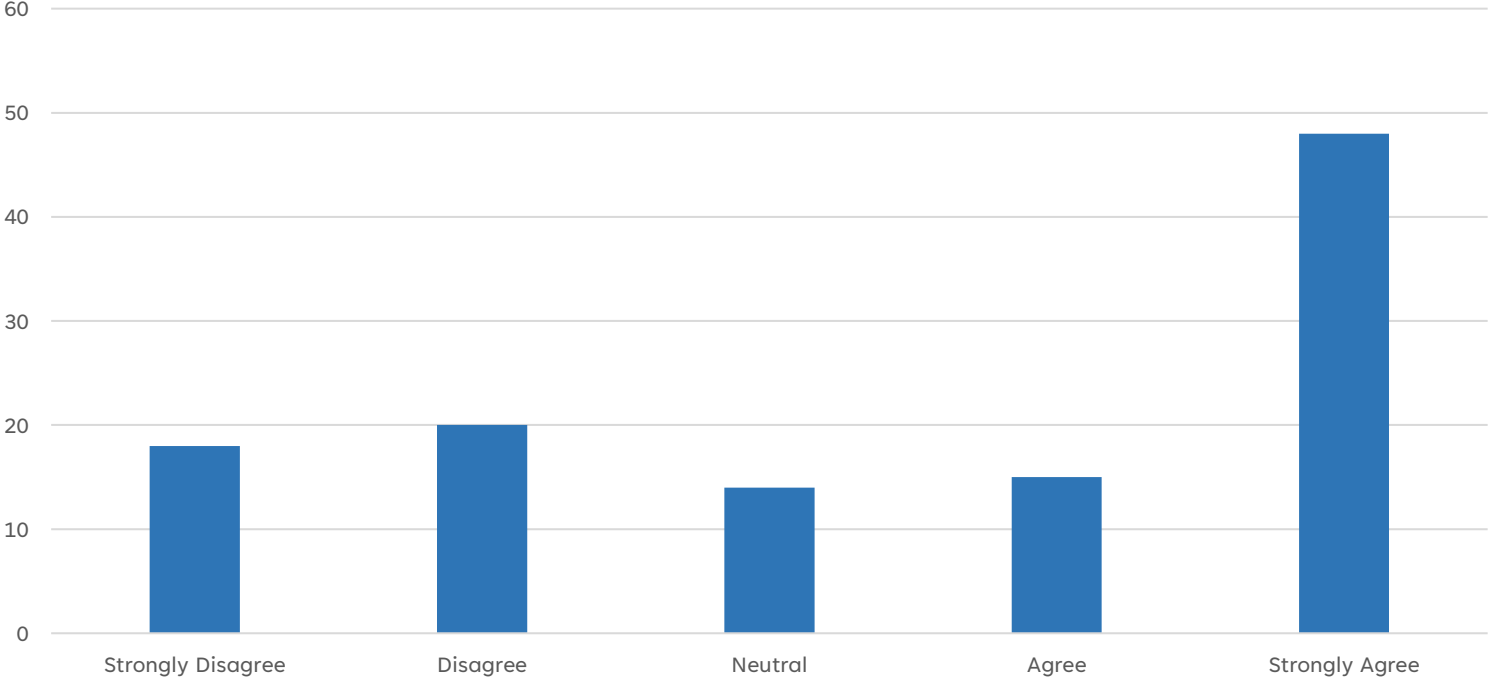
