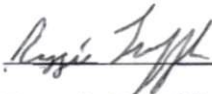


**MINUTES OF COUNTY FINANCES
TREASURER'S REPORT MAY 2023**

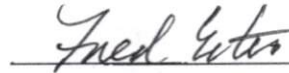

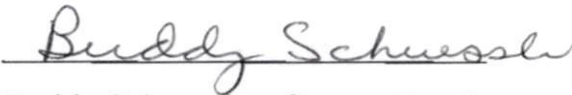
